All Children

Your rights are just as important as another child's rights. This is an important part of the Convention because some children are harder to reach and protect then others. You must not be treated badly or excluded because of who you are.

Article: All children have the right to

- 1 Protection of they are under the age of 18
- 2 Protection from discrimination
- 3 Their best interests being protected
- 26 Help if you are poor or in need

Fact

- Children living in direct provision accommodation are being denied "normal family life". According to Education Minister Jan O'Sullivan.
- According to the CSO 55% of Irish Travellers had completed their education before the age of 15.
 This compares with only 11% for the general population.

- 2. Do some children get treated unfairly or suffer from discrimination because of who they are, where they are from or what they have?

Article: All children have the right to 2 Protection from any and all forms of discrimination

- Children from "visible minority" groups are bullied more than their peers, facing racist slurs as well as physical violence. The Immigrant Council of Ireland (ICI)
- 2 toddler traveller children applying for passports were assigned criminal intelligence numbers recently.

Nobody should be left behind and as children your needs must always be considered. You have a right to have special care if you need it. You should not live in poverty and a basic standard of care should be provided.

25 Your care by others must be reviewed

26 Help if you are in need

27 A decent standard of living and care to meet your physical and mental needs

- There are over 800 young people homeless.
- Over 6,000 are growing up in State care.
- There are 130,000 more children living in poverty since the recession that started in 2008.
